

COMPANION CONGREGATION PARTNERSHIP COVENANT

What is a partnership?

The partnership is made by two churches, one church from the Evangelical Lutheran Church in America in the United States and one church from the Iglesia Luterana Agustina de Guatemala. In this case, the Iglesia Luterana Agustina Mensajeros de Cristo of the ILAG is renewing a partnership with Grace Lutheran Church of the ELCA, St. Paul Area Synod.

The partnership is a relationship based in the love of Christ. Communication and understanding of each other are important parts of the relationship.

The most important part of the partnership between the two churches is Christ, who calls us into relationships of mutual love and respect. The members of the two churches must love each other. "For the whole law is summed up in a single commandment, 'You shall love your neighbor as yourself.' If, however, you bite and devour one another, take care that you are not consumed by one another." (Galatians 5:14-15)

This means that the members of the two churches should:

- Have mutual respect: Grace Lutheran Church cannot ask or obligate the Iglesia
 <u>Luterana Agustina Mensajeros de Cristo</u>.

 And the Iglesia Luterana Agustina Mensajeros de Cristo cannot ask or obligate
 <u>Grace Lutheran Church</u> to do something that the members of that church cannot
 do or do not wish to do.
- Strive for mutual understanding: The two congregations need to recognize that their partners are from different countries and have different cultures and customs.
- Communicate frequently: The two congregations should strive to get to know each other and develop a relationship based in God, sharing their joys, their sorrows, and the activities of each church.
- Be willing to understand one another in order to create a relationship of friendship in Christ that is long lasting.

The partnership is a relationship of commitment that the two churches involved in the partnership make.

Grace Lutheran Church commits to:

- Accompany the <u>Iglesia Luterana Agustina Mensajeros de Cristo</u> in the walk of Christ. This means that:
 - The members of <u>Grace Lutheran Church</u> will pray for all the members of the <u>ILA Mensajeros de Cristo</u> every Sunday.
 - The members of <u>Grace Lutheran Church</u> will visit every other year, if possible, the members of the church in their community
 - The members of <u>Grace Lutheran Church</u> will support the members of the church and the church in a material way to the best of their ability, with the condition that the aid will be for the common benefit.
 - The members of <u>Grace Lutheran Church</u> will write to the members of the <u>ILA Mensajeros de Cristo</u> a letter at least every three months.
- This commitment of the partnership is realized for a period of three (3) years
 - The partnership can be renewed after three (3) years depending on the capability of <u>Grace Lutheran Church</u> of sending people in order to visit the members of the <u>Iglesia Luterana Agustina Mensajeros de Cristo.</u>
 - The partnership can be terminated before the three (3) years have been completed depending of the behavior of the members of the <u>ILA</u> <u>Mensajeros de Cristo.</u>
 - The partnership can be terminated by <u>Grace Lutheran Church</u> after the three years of commitment have been accomplished.

The Iglesia Luterana Agustina Mensajeros de Cristo commits to:

- Accompany <u>Grace Lutheran Church</u> in the walk of Christ. This means that:
 - They will pray for all the members of <u>Grace Lutheran Church</u> every Sunday.
 - They will attend to the members of <u>Grace Lutheran Church</u> to the best of their ability when they visit their community.
 - They will write to the members of <u>Grace Lutheran Church</u> at least one letter every three months.
 - They will not think of the members of <u>Grace Lutheran Church</u> or the churches themselves as a bank, a loan institution or a beneficiary institution because this is a partnership of relationship based in Christ.
- This commitment of partnership is made for a period of three (3) years:
 - ▼ The partnership can be renewed after three (3) years.
 - The partnership can be also terminated before the three years depending on the behavior of the members of Grace Lutheran Church.
 - The partnership can be terminated when the three-year commitment is ended at church's discretion.

The churches, <u>Iglesia Luterana Agustina Mensajeros de Cristo</u>, and <u>Grace Lutheran Church</u> commit to:

▼ Send their communications through the members of the Pastoral Team of the Iglesia Luterana Agustina Mensajeros de Cristo. This will ensure that

the communication and translation of the communication is delivered to both churches in an exact and clear way. This is also in order to keep a file of the communications and to have a history of the partnership from its beginning and a documentation of how the relationship has grown with the help of God.

The members of these Lutheran Churches commit to treat the members of the Lutheran Churches as equals, as their brothers and sisters in Christ and

to not denigrate them or treat them poorly.

The members of Grace Lutheran Church cannot force the community in need to accept a project they do not need. Grace Lutheran Church need to respect the needs of the community. But if the community has a need for a project that Grace Lutheran Church support, can ask that the project is completed within a certain period of time.

In the same way, if the Iglesia Luterana Agustina Mensajeros de Cristo takes on any project, it cannot obligate or demand more resources than what they have been given; instead, they have to respect and accept the

help that is provided to them.

In the management of funds, the Iglesia Luterana Agustina Mensajeros de Cristo commits to be transparent and to turn in a report of how funds have been managed and to use the provided resources correctly. They commit to use the funds for the purpose for which the funds have been designated.

WE SIGN THIS COVENANT AS A COMMITMENT TO THIS PARTNERSHIP, TRUSTING THAT GOD WILL GUIDE US IN THIS MINISTRY AND THIS IOURNEY IN CHRIST WHICH HE HAS COMMENDED INTO OUR HANDS.
